MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITY "ST KLIMENT OHRIDSKI" – BITOLA

AND

UNIVERSITY "UKSHIN HOTI" PRIZREN

This Memorandum for establishing inter-institutional academic cooperation is signed by University "St Kliment Ohridski" – Bitola, Republic of North Macedonia, represented by its Rector, Prof. Dr Sasho Korunovski, and University "Ukshin Hoti" Prizren, Republic of Kosova, represented by its Rector, Prof. asoc. Dr. Samedin Krrabaj (referred to as parties).

The parties hereby agree to the following:

Article 1

The subject of this Memorandum is to regulate the relations of cooperation between University "St Kliment Ohridski" – Bitola and University "Ukshin Hoti" Prizren, to define the academic and scientific fields of mutual interest, as well as the manner and modalities of their realization.

Article 2

In accordance with this Memorandum and the resources at disposal, University "St Kliment Ohridski" – Bitola and University "Ukshin Hoti" Prizren, agree to incorporate within the scope of mutual cooperation, activities and programs, such as:

1. exchange of staff,
2. exchange of students,
3. joint scientific-research projects,
4. participation in various academic conferences,
5. staff training programs, and
6. other areas of mutual interest.

Financial matters related to activities deriving from this Memorandum shall be considered and agreed upon for every case individually.

Article 3

University units/departments of both institutions can enter into mutual relations of cooperation and engage in project activities in areas of particular interest for them. For that purpose, they are to define the type, the scope and the principles of realization of such cooperation in annexes/protocols within this framework Memorandum.

Article 4

Both institutions should designate their contact person to develop and coordinate the specific activities, or programs agreed upon.

Article 5

Complete realization of this Memorandum is dependable on the resources at disposal intended to cover joint activities.

Any responsibility and costs related to projects deriving from this Memorandum shall be covered in accordance with the established practice and policy of each institution, as well as the conditions and obligations towards financial institutions.

Article 6

This Memorandum may be altered and/or amended upon mutual consent.

Any proposals to alter or amend this Memorandum shall be subject of separate annexes to this Memorandum.

Article 7

This Memorandum shall become effective upon formal signature by both parties and will remain current for five (5) years. It may be automatically renewed for additional period's office five (5) years, based upon mutual consent.

Either institution may terminate it by providing the other party a written notice no later than 6 (six) months prior to the expiration date.

Article 8

This Memorandum is drawn up in 2 (two) identical copies, in English language. Both copies are considered of equal validity and equally binding for both parties.
